



Long-Term Care Supports & Services

Long-term care supports and services (LTSS) provide daily health care and living needs to qualified individuals (of all ages) who have a disability or long-term illness in the community or in an institutional setting.

LTSS include, but are not limited to...

- Adaptive Aids
- ADL
- Behavioral Supports
- Dental
- Financial Management
- Habilitation
- Personal Care

- Minor Home Modifications
- Nursing
- Residential Assistance
- Respite
- Specialized Therapies
- Supported Employment
- And more...

"Independence is not measured by the number of tasks we can do without assistance, but by the quality of life we can lead WITH assistance."

Generally speaking...

- Some LTSS programs do not consider family income.
- Access to Medicaid Waiver programs is lengthy!
 - Name placed on an "interest list"
 - Keep contact information current!
 - Yearly contact required!
- LTSS program eligibility is determined when services are offered.

- LTSS programs include but are NOT limited to Medicaid Waiver programs, HCS group homes and ICF-IID facilities.
- Each LTSS program has different eligibility requirements, rules, funding amounts and service options.
- LTSS program options vary by county.
- Service rates vary per LTSS program.
- Institution-based care costs are considerably higher than community-based care.

DADS Community-Based LTSS Programs

Medicaid Waiver programs are the most commonly known LTSS.

Medicaid Waiver programs administered through the Texas Department of Aging and Disability Services (DADS)

- Community Based Alternatives (CBA) no longer at DADS
- Community Living Assistance and Support Services (CLASS)
- Deaf-Blind/Multiple Disability (DBMD)
- Home and Community Based Services (HCS)
- Medically Dependent Children Program (MDCP)
- Texas Home Living (TxHmL)

Targeted HCS Diversion Slots

- The Texas Department of Aging and Disability Services (DADS) may make available a targeted HCS waiver slot to an individual with an intellectual disability who is determined to be at imminent risk of admission to an SSLC.
- A slot is *not* available to an individual who has criminal charges pending or who is eligible for admission to the forensic SSLC.

IDD Community Services

IDD Community Services (Local Authority): Services and supports, such as day habilitation, community support and respite provided to assist persons to live in the community.

<u>Healthcare Transformation Initiatives</u>

Program is a 5-year federally approved waiver (also
known as the 1115 Waiver) that allows providers to
reshape healthcare in their communities and improve
access for low-income individuals to affordable care.

Consumer Directed Services (CDS)

- Gives you a choice about how your services are managed:
 - Agency option (Agency Managed)
 - Service Responsibility option (Co-Managed)
 - Consumer Directed Services employer (Self-Managed)
- Services that can be self-directed vary by program

DADS Institution-Based LTSS

Intermediate Care Facility for Persons with an Intellectual Disability or Related Condition (ICF-IDD) – An ICF-IID is state operated facility that provides 24 hour residential and habilitation services to qualified Individuals.

There are two types of ICF-IID in Texas.

- Community-based home (small up to 8 people, medium 9 to 13 people, and large - 14+ people)
- State Supported Living Centers (SSLCs) large institution for apx. 70 – 550 residents

* Texas maintaines 13 SSLCs * SSLC resident population as of October 2013: 3524 Texas SSLCs have and continue to be monitored as part of a settlement agreement with the Department of Justice, Office of Civil Rights for "serious deficiencies at multiple facilities, a long history of abuse, neglect, and exploitation and failure to serve Facility residents in the most integrated setting appropriate to their individual needs".

Nursing Facility (NF) – residential facilities that provide services for individuals whose medical condition regularly requires the skills of licensed nurses.

The 83rd Legislative Session

Over the course of the 2014-2015 biennium:

- 5,700 new people will be served in Medicaid waiver programs.
- The number of people served in the promoting independence program will increase by 1,150.
- Senate Bill 7 (SB7) signed into law.

Community First Choice Option (CFCO)


provides habilitation and attendant care services to people on the Medicaid community waivers interest lists. Scheduled for implementation in March 1 2015, pending federal approval.

Medicaid Managed Care Initiatives

changes how Texas manages and pays for medical and LTSS services for people with IDD in CLASS, DBMD, HCS, TxHmL

also effects medical and LTSS in MDCP

Looking Ahead: Sunset Commission Recommendations regarding DADS

Composed of legislators and public members, periodically evaluate a state agency to determine if the agency is still needed and to explore ways to ensure that the agency's funds are well spent.

The Sunset Commission Staff Report: DADS recommends closure of 6 of the 13 SSLCs

 provides health-care and long-term services and supports through a medical plan

Youth Empowerment Services Waiver - The YES Waiver program is administered through the Texas Department of State Health Services (DSHS)


- for individuals who have a Serious Emotional Disturbance (SED)
- available in three counties (Bexar, Tarrant, Travis)

Children with Special Health Care Needs (CSHCN) Services Program

CSHCN is administered through the Texas Department of State Health Services (DSHS) and helps

- children under age 21 with special health-care needs who meet eligibility criteria
- people of any age with cystic fibrosis

Non-educational Community-based Support Services

- Funds may be used only for eligible students with disabilities who, without the provision of noneducational community-based support services, would remain or would have to be placed in residential facilities for education reasons.
- Parents must request services through an application process at their Local Education Agency (LEA).

Texas Department of State Health Services - Mental Health Services

DSHS Children's Mental Health serves children ages 3 through 17 with a diagnosis of mental illness (excluding a single diagnosis of substance abuse, intellectual disability, autism or PDD) who exhibit serious emotional, behavioral or mental disorders and who:

- Have a serious functional impairment; or
- Are at risk of disruption of a preferred living or child care environment due to psychiatric symptoms; or
- Are enrolled in a school system's special education program because of serious emotional disturbance
